Attached is a revision to the submittal for Changes to Technical Specification 3/4.3.1 and 3/4.3.2 transmitted via letter dated January 13, 1995. This revision corrects an administrative error in the submittal package. On TABLE 4.3-2, Engineered Safety Features Actuation System Instrumentation Surveillance Requirements, Functional Item 5c - Doghouse Water Level-High (Feedwater Isolation Only) - was inadvertently omitted from page 3/4 3-36. The markup previously submitted did not reflect a correction to Amendment No. 56/37 issued by the NRC to McGuire Nuclear Station on June 16, 1986. This administrative revision reinserts Functional Item 5c. Functional item 5c was not part of the technical changes contained in the above referenced submittal.

Two editorial corrections were also made. The first is in the headings of columns 5 and 6 on TABLE 4.3-1, page 3/4 3-12. The second is a typo correction in "Insert A" for ACTION 7 on page 3/4 3-7 of the original submittal. The remainder of the submittal has been reviewed and is correct as submitted.




