SUBJECT: NRC INSPECTION REPORT 50-397/95-27

This refers to the inspection conducted by Mr. T. W. Dexter of this office on August 14-18, 1995. The inspection included a review of activities authorized for your Washington Nuclear Power Supply System, Unit 2, facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements.

It was identified that a security event involving the failure to properly secure a door providing access into the protected area was a violation of the licensee's physical security plan. This failure constitutes a violation of minor significance and is being treated as a Non-Cited Violation, consistent with Section IV of the NRC Enforcement Policy.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material will not be placed in the Public Document Room.
