Subject: Inspection Report Nos. 50-317/91-29 and 50-318/91-29

This refers to the combined safety inspection 50-317/91-29 and 50-318/91-29 conducted by Mr. Herbert Kaplan of this office on November 18-21, 1991, at the Calvert Cliffs Nuclear Power Plant, Units 1 & 2, in Lusby, Maryland. Mr. Kaplan discussed the results of the inspection with Mr. Thornton and other members of your staff at the conclusion of the inspection.

This inspection focused on activities important to public health and safety, and was directed toward your response and corrective actions regarding open and unresolved items in the area of welding and non-destructive examination (NDE). The items covered the period between March 1989 and April 1990. On the basis of the evidence provided by your staff, the inspector closed all but one item involving NDE. No response to this letter is required. Your cooperation is appreciated.
