# PANEL SUBJECTS

- Plant Status and Schedule

Bill Johnson gave plant status. Highlights included Unit 1 being in Mode 5 with preparations being made for Mode 4. The plant is scheduled to be ready for Mode 4 entry on January 12.

- Allegation Status

The Panel briefly reviewed the status of open allegations. This area will be covered in more detail in the next meeting when Russ Wise can be available.

- Review Restart Action Plan

A draft revision was distributed to Panel members. Panel members are requested to provide comments and additional proposed changes to B. Johnson by January 10, 1994. Concurrence review will begin on January 11.

- Restart Issue Closure Status

The Panel discussed restart issue closure status.

- Regional Inspection Planning

Bill Johnson discussed the status of the necessary regional inspections to address restart issues. A copy of the updated inspection schedule is attached to these meeting notes. DRSS has obtained assistance from Region V to perform a security inspection January 10, 1994. There are no

restart issues in this area. Three Region IV personnel will conduct followup on various items remaining open after restart inspections January 10-14. Diesel generator followup items will be inspected January 18-21. Followup on service request backlogs will be conducted on or after January 24 with the unit in Mode 3.

# - ORAT Inspection Planning

Jeff Jacobson discussed his plans for the second segment of the ORAT inspection. It will be conducted January 12-21, 1994. The exit meeting will be open to the public and will be held at about 9:30 or 10 a.m. on January 21. He is planning a press conference following the exit meeting. There will be a pre-exit team meeting at 2 p.m. on January 20. A Quick Look letter will be issued promptly after the inspection, if issues requiring resolution prior to restart are identified.

- Timing of NRC Restart Approval Process, Concurrences, and Notifications
   Sam Collins discussed a time line of required actions in this process.

- STP Response to Generic Letter 93-04 on Control Rod Single Failures

  Lawrence Kokajko discussed this item, noting that the licensee was preparing a JCO to permit startup pending final resolution of this issue. NRC review of the JCO will be added to the Restart Action Plan.
- Review Status of Panel Action Items

- DRP will prepare four inspection reports to assign tracking numbers to DET items which are not considered to be restart issues. Reports 9348 through 9351, one for each DET functional inspection area, will list DET findings which are not restart issues. They are under preparation.
- (Closed) Sam Collins will contact Region II to set up a conference call to discuss the restart process used for Region II plants.
- (Closed) The Panel Chairman will continue to provide input to the NRC restart review schedule, re: internal and external briefings.
- (Closed) Issue Revision 1 of the Restart Action Plan DRP
- Brief the Regional Administrator on current status of allegations -Panel
- Determine whether restart public meeting should be transcribed Panel

- ((Closed) Determine the method of assessing licensee's assessment initiatives. This will be covered in Inspection 9406 and in the ORAT inspection.
- Perform an internal audit of the RIV Restart File following file completion, probably in December 1993 - Panel
- (Closed) Panel members review Restart Action Plan checklist item status prior to the next Panel meeting
- (Closed) Panel Chairman discuss restart issue closure policy with Joe Sheppard
- (Closed) DRP will invite the NRR Human Factors Branch to assist in NRC followup of the MOVATS event. Assistance was provided for Inspection 9354.
- (Closed) L. Kokajko will set up a conference call with the licensee to get details on steam generator tube defects when available.
- (Closed) L. Kokajko will discuss the issuance of a Licensee Event Report on fuel oil testing with the licensee. An LER is to be submitted.
- (Closed) D. Loveless will determine whether any of the system certification walkdown punchlist items should be documented in service requests. The licensee has stated that the punchlist items will be worked off or converted into service requests prior to restart. Progress is being made in working off the items.
