# PANEL SUBJECTS

- NRC Restart Approval Process, Concurrences, and Notifications

This was a brief meeting held at the site following the licensee's presentation on the resolution status of the restart issues listed in the Confirmatory Action Letter of February 5, 1993, and its two supplements. The panel members agreed that, pending the successful completion of main feedwater isolation valve bypass valve testing and verification of completion of the worker and supervisor briefings on management expectations regarding work practices, the licensee had resolved the restart issues. The Panel recommended that the Regional Administrator concur in the restart of Unit 1 after the licensee completes these two items.

- NRC Restart Approval Process, Concurrences, and Notifications

The panel reviewed the open items requiring confirmation following the public meeting on February 14, 1994. Both the valve testing and the worker training items had been completed.
