### PANEL SUBJECTS

- Congressional Investigation

A congressional subcommittee and/or the GAO is considering an investigation into the NRC handling of the restart approval process for STP, Unit 1, and the NRC handling of allegations related to STP. The Panel will cooperate fully if an investigation is conducted and will provide any necessary information to assist the investigators. The NRC Office of Congressional Affairs has been informed of the GAO interest and has already provided some information to congressional subcommittee staff members.

- Unit 2 Inspection Planning

Monitoring of Unit 1 performance under recently revised programs will provide valuable input to the resolution of the programmatic issues for Unit 2. The resident inspector staff will be asked to provide information to the Panel in this regard.

- Next Panel Meeting

The next Panel meeting was scheduled for April 19. The meeting will focus on the Unit 2 Restart Action Plan and the necessary inspections to support issue resolution for Unit 2. Allegation status will also be reviewed.

- Status of Panel Action Items
- Items from past meetings:
  - Perform an internal audit of the RIV STP Restart File Panel

- Bill Johnson will prepare a restart action plan for Unit 2 to present to the Panel for discussion. This was presented at this meeting (4/12/94). A revised draft will be distributed to Panel members for discussion at the next meeting.
- Bill Johnson will include the Panel Assessment of Licensee Performance in the next resident inspection report.

- New Items:

 Bill Johnson will draft a letter to acknowledge receipt of the Unit 2 Operation Readiness Plan.
