

The MPQAD response to SMO concerning the above item is detailed below.

The referenced short term schedule, dated 4/27/84, does not include PQCI's M-2.00 or P-1.10.

The "list of available certifications by PQCI, dated 4/13/84" appears to be a slide used in Management Review for Turbine Roll. This slide detailed PQCI's anticipated for Phase 2 work, and was used strictly for presentation purposes. Since PQCI's P-1.90, PI-2.90, P-2.30, and PI-1.90 are used exclusively for Phase I reinspections, they did not appear on this listing.

Official records of certifications are available for review through normal channels. MPQAD does not perform inspections prior to certification, and has formal mechanisms in place to preclude this.
