SUBJECT: FORT CALHOUN STATION SITE SECURITY PLAN, REVISION 9

This acknowledges the receipt of your letter dated August 23, 1995, by which you transmitted Revision 9 to the Fort Calhoun Station Site Security Plan.

The regional staff has reviewed the submitted revision and found the changes to the subject letter and the attachments thereto to be consistent with the provisions of 10 CFR 50.54(p) with the following exception:

- The change to paragraph 10.1 of the Security Plan (made in response to Generic Letter 93-07), incorporates the requirements previously listed in Technical Specifications (TS) 5.5.2.8, i.e., audit of the site security plan and implementing procedures. However, as originally approved, TSs 5.5.2.9 and 5.5.2.10 imposed additional requirements upon those areas previously listed in TS 5.5.2.8. These requirements from TSs 5.5.2.9 and 5.5.2.10 also need to be incorporated into paragraph 10.1 of the Security Plan.

The above exception was discussed during a phone conversation between Messrs. J. Sefick and D. Leiber of your staff and D. Schaefer of this office on September 5, 1995. Your other changes contained in Revision 9 are acceptable for inclusion in the plan.

The enclosures to your letter contain Safeguards Information of a type specified in 10 CFR 73.21 and are being withheld from public disclosure.

SUBJECT: Revision 9 to the Fort Calhoun Station (FCS) Site Security Plan


Attached is Revision 9 of the FCS Site Security Plan, including a detailed summary listing of changes. This revision reinstates the requirement to have riot batons readily available to each designated armed responder; this requirement was removed in Revision 8 to the Plan, but was not accepted by the NRC as a 50.54(p) change (Reference 2). Changes to paragraphs 8.3.2 and 10.2 are follow-up corrective actions resulting from the OPPD response (Reference 3) to NRC Inspection Report 50-285/95-03. Other changes reflect revised review requirements of the administrative Technical Specifications allowed by Generic Letter 93-07. All changes are identified with revision bars in the right margin.

This revision has been determined not to degrade the effectiveness of current security plans, and has been approved in accordance with 10 CFR 50.54(p).

This submittal contains safeguards information and must be controlled in accordance with 10 CFR 73.21. Controlled copy numbers 6, 7 and 18 are enclosed. Controlled copy numbers 19 and 20 are being transmitted to Region IV. Controlled copy number 8 is being transmitted to the FCS Senior Resident Inspector.
