Technical Specification Change to Reduce Required Ice Weight

Attached is a proposed revision to Technical Specification 3/4.6.5 to reduce the required ice weight in the containment ice condensers at McGuire Nuclear Station. This proposed revision would reduce the weight of ice in the ice condensers of each unit from 2,099,790 lbs (1081 lbs/basket) to 1,516,800 lbs (781 lbs/basket).

In addition, an obsolete footnote that appears on page 3/4 6-34 is being deleted.

The marked-up Technical Specification pages (as well as revised original pages) are contained in Attachment I, the justification and safety analysis in Attachment II, and a No Significant Hazards Analysis in Attachment III.

This amendment request has been reviewed by the McGuire Plant Operations Review Committee and the corporate Nuclear Safety Review Board. It is considered to be a Cost Beneficial Licensing Action, in that it is expected to save an average of at least \$250,000 per outage in averted surveillance and maintenance costs.
