TMI-1 RESTART HEARING: PUBLIC DISSEMINATION  
OF NUREG-1020 LD

In accordance with the NRC procedure for Board Notification, the following information is being provided directly to the Commission. The Boards and parties are being informed by copy of this memorandum.

By Board Notification BN-83-152, dated October 3, 1983, the staff provided complete versions of NUREG-1020 "GPU v. B&W Lawsuit Review and Its Effect on TMI-1" to the Commission, Board and Appeal Board, and public versions of NUREG-1020 to the parties to the proceeding. This split distribution was based upon a determination by the Director of the Office of Investigations that public release of the complete version (designated NUREG-1020 LD to denote limited distribution) would have been likely to compromise pending investigations. However, the Director of the Office of Investigations has now determined that NUREG-1020 LD may be publically released at this time. Accordingly, copies of NUREG-1020 LD are being provided herewith to the TMI-1 Restart proceeding parties.

Also enclosed is a previously withheld memorandum dated November 7, 1983 from H. Denton (NRC) to B. Hayes (NRC) which provided additional detailed information concerning the matters discussed in Category 10 (Management/Integrity) of NUREG-1020 LD. The Director of the Office of Investigations has determined that this memorandum may now be released.
