SUBJECT: SUPPLEMENT 1 TO NUREG-0737: REQUEST FOR MODIFICATION OF COMMISSION ORDER DATED FEBRUARY 21, 1984

By letter dated March 20, 1984 (No. 1033), and supplemented by letter dated May 10, 1984 (No. 1047), you requested that we extend the completion dates for certain items contained in the Commission Order dated February 21, 1984 relating to Supplement 1 to NUREG-0737. Specifically, you request that the submission dates for the DCRDR Summary Report and the report discussing the application of Regulatory Guide 1.97 be extended from April 15, 1984 to June 30, 1984. Your letter also requests that the submittal date for implementation schedules for design improvements identified in these reports be extended from April 15, 1984 to January 31, 1985.

In taking this action, we reviewed the justifications you provided for the delays in the submission dates for the two reports. We found that these justifications provided adequate basis for modification of the Commission's Order. We also found that the delays requested are relatively short and should have little impact, if any, upon the final implementation of the programs for design improvements in the control room and instrumentation systems. We have granted the delays requested above. A copy of the extension decision is enclosed.
