I have been asked to reply to your mailgram to President Reagan in regard to the Shoreham nuclear plant.

As you are aware President Reagan has spoken out many times in favor of the nuclear generation of electric energy. The question of whether the Shoreham nuclear plant can receive a license for operation is presently being considered by the Nuclear Regulatory Commission under their regulations designed to protect the health and safety of the public. The two major issues currently being considered by the Commission involve the provision of reliable emergency electric power to the facility in the event of an accident, and the state of emergency preparedness planning for the area surrounding the facility.

We recognize your concern in regard to the need for reliable electric service on Long Island. Thank you for expressing your views on this important issue.
