SUBJECT: NRC GENERIC LETTER 89-10 INSPECTION AT EDWIN I HATCH NUCLEAR PLANT
DURING THE WEEK OF FEBRUARY 24-28, 1992

This letter is to confirm the above dates for a Nuclear Regulatory Commission inspector at your Edwin I Hatch Nuclear Plant. The inspection will examine the program you have developed in response to Generic Letter 89-10, "Safety-Related Motor-Operated Valve Testing and Surveillance." The dates were agreed to during telephone conversations between Steve Bethay of your Licensing staff and F. Jape of this office.

As discussed with Denver Atwood on January 22, 1992, it is our understanding that you will forward us the following information to aid on preparing for the inspection:

1. The procedure or other documents that describe your MOV program and the method used for design basis delta pressure calculations.
2. A list of the valves in the program (if not already included in the program description requested in 1 above).
3. A list of the valves for which you have completed the design basis reviews.
4. A list of the valves that have been diagnostically tested to verify their capabilities in accordance with the program.
