SUBJECT: NRC INSPECTION REPORT NO. 50-382/92-01 (NOTICE OF VIOLATION)

This refers to the inspection conducted by an NRC team from Region IV accompanied by the NRR Project Manager on January 6-10, and to the discussions onsite between Mr. T. Westerman of this office and Messrs. T. Brennan and R. Azzarello of your staff on January 30, 1992. The inspection included a review of your engineering activities authorized for your Waterford Steam Electric Station, Unit 3, facility. At the conclusion of the inspection, the findings were discussed with members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the enclosed report. The inspection indicated that the final formalization of the transition of Waterford 3 engineering under the Entergy Operations organization was in process with Corporate Directives to be issued by the end of February. The formation of peer groups utilizing personnel from all three Entergy Operations sites appeared to be a strength for the further enhancement of Entergy Operations engineering activities. Overall the inspection indicated good progress in implementing enhancements and improvements to your engineering programs.

Based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). The violations are of concern because they indicate a weaknesses in your configuration control program and with your process for the identification of temporary alterations on drawings utilized by control room personnel.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.
