SUBJECT: REPORT NOS. 50-280/84-19 AND 50-281/84-17

On June 3 - 7, 1984, NRC inspected activities authorized by NRC License Nos. DPR-32 and DPR-37 for your Surry Nuclear Power Station. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed inspection report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.
