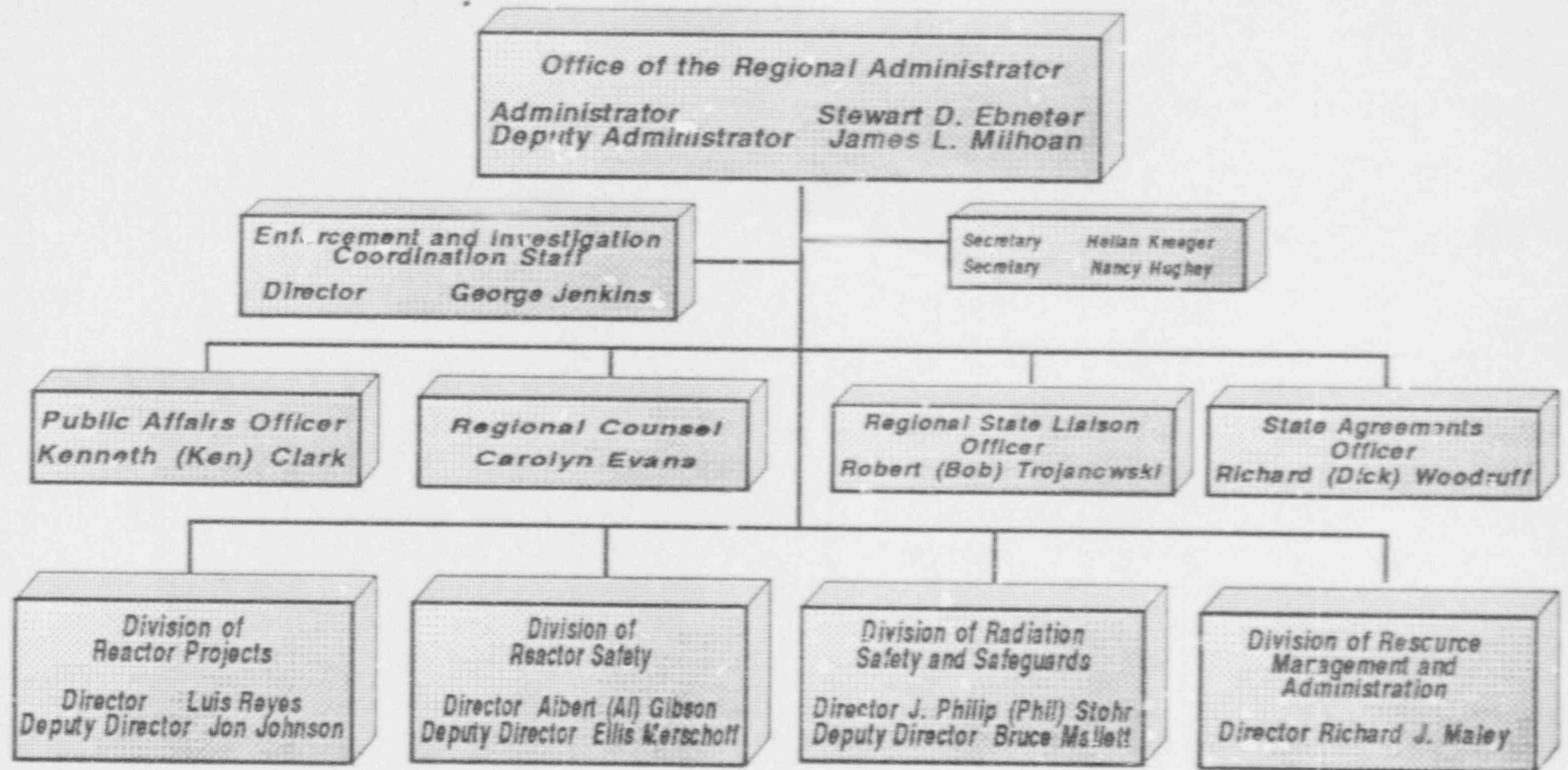

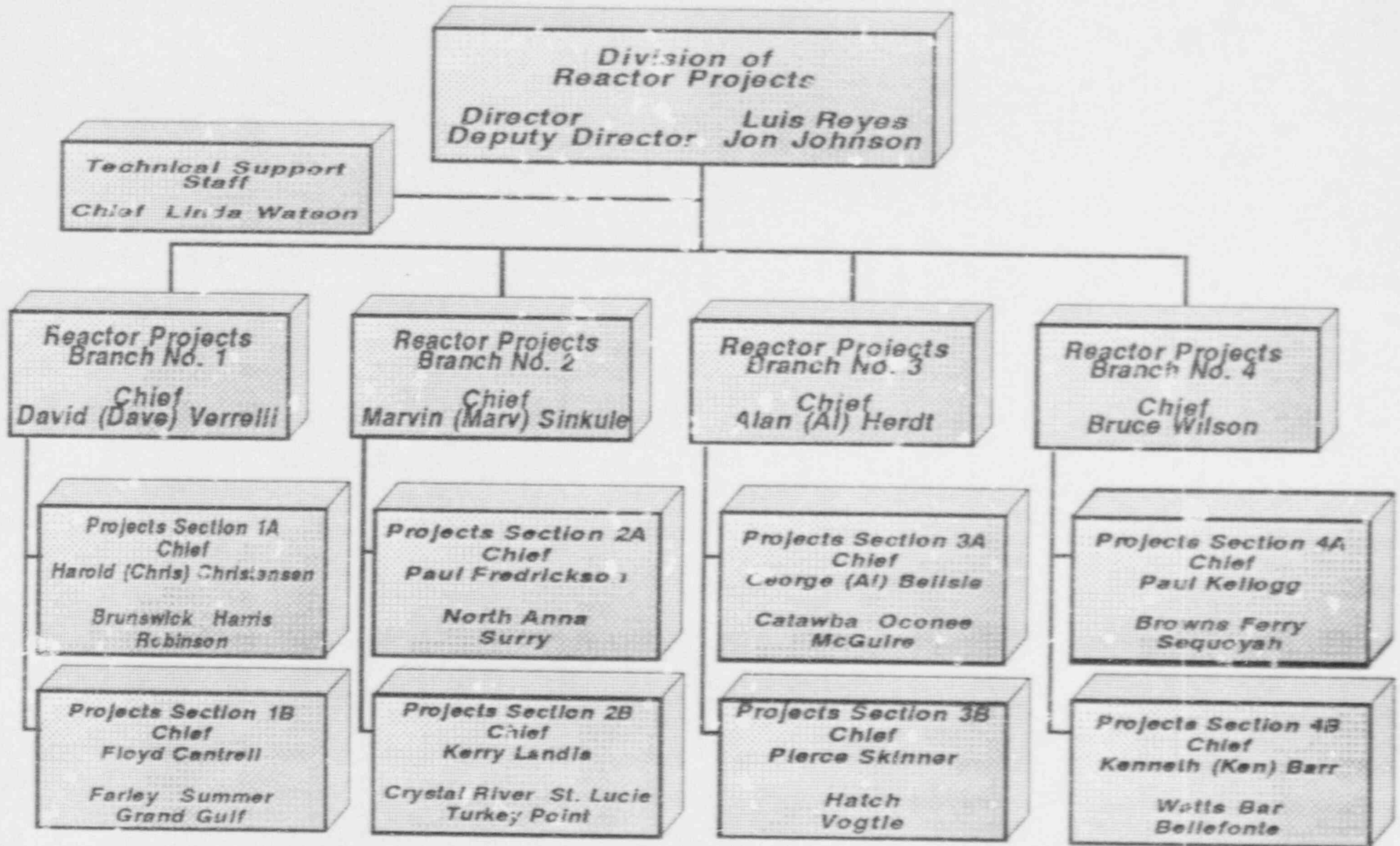

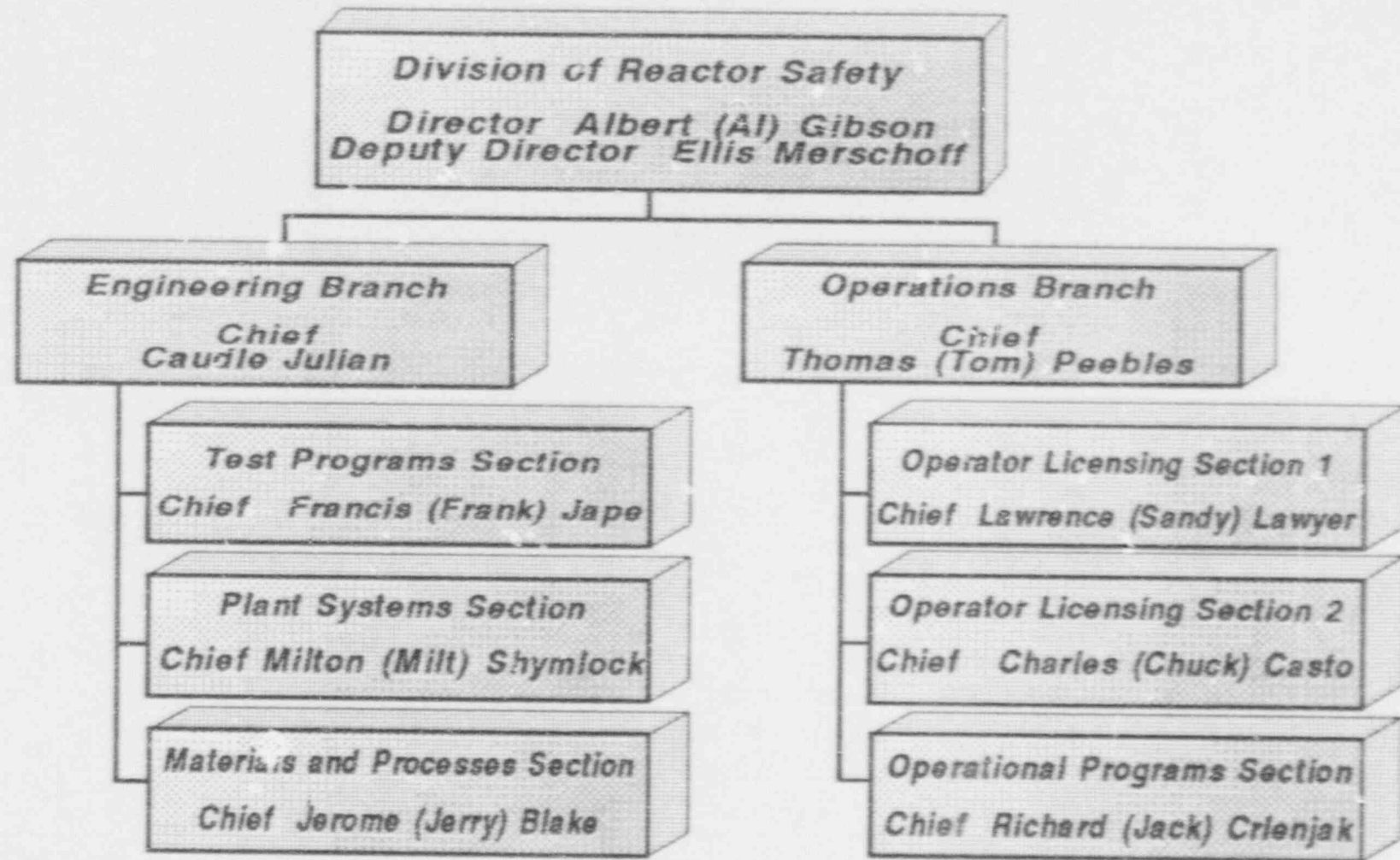


U.S. NUCLEAR REGULATORY COMMISSION REGION II ORGANIZATION CHART
