SUBJECT: NRC INSPECTION REPORT 50-298/95-10

This refers to the inspection conducted by M. Miller, and others listed in the enclosed report, of this office on July 9 through August 19, 1995. The inspection included a review of activities authorized for your Cooper Nuclear Station facility. At the conclusion of the inspection, the findings were discussed with Mr. John Herron and those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements.

No violations of NRC requirements were cited during this inspection period and those nonconforming conditions that were self-identified or self-disclosing were aggressively addressed by plant staff and management.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter, and its enclosure, will be placed in the NRC Public Document Room (PDR).
