Lusher of this office inspected Seabrook emergency preparedness program aspects important to public health and safety. That inspection included selected procedure and record reviews, interviews, emergency scenario walk-through examinations, and inspector observations. Preliminary inspection findings were discussed with Mr. Diprofio and other members of your staff at the conclusion of the inspection. Official inspection findings are contained in the enclosed report.

This inspection found no significant safety or compliance issues. Effective implementation of the emergency preparedness program and the following strengths were identified.

- The emergency response organization notification system.
- Quality of the site support manuals and their detailed procedures.
