Briggs of this office on April 17-20, 1984 of activities authorized by NRC License No. CPPR-135 at Seabrook Station Unit 1, Seabrook, New Hampshire and to the discussions of our findings held by Mr. Briggs with Mr. Kann and others of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter.
