Gentlemen:

Enclosed is a letter from Dennis Kwiatkowski of the Federal Emergency Management Agency (FEMA) dated November 21, 1991, transmitting to NRC the FEMA Region VII report for the August 7-8, 1991, emergency exercise at Wolf Creek Generating Station. The State of Kansas and the Counties of Coffey, Anderson, Lyon, and Sedgwick participated fully in the exercise. A copy of the report has been forwarded by FEMA to the State of Kansas.

The FEMA report dated November 5, 1991, identified no deficiencies and seven areas requiring corrective action. You are requested to followup with offsite officials on the areas requiring corrective action.

Based on the results of the August 7-8, 1991, exercise, emergency response plans and preparedness site-specific to the Wolf Creek Generating Station are adequate to provide reasonable assurance that appropriate measures can be taken offsite to protect the health and safety of the public in the event of a radiological emergency at the site.
