In reference (2) the NRC identified several differences between the NRC position on NUREG 0737 Ifem I.C.6 and the Pilgrim Station procedures. Reference (3) stated that the station policy should conform to I.C.6 considering ALARA and personnel resource requirements and that justification will be provided for any deviation. Reference (4) informed the NF, that Nuclear Operations Procedure (NOP) 8301 titled "Conduct of Operations" incorporating I.C.6 policy was issued June 17, 1983.

After review of the referenced correspondence, NOP 8301, and applicable station procedures the staff believes that the concerns described in reference (2) have not been adequately addressed. In addition, a discussion of deviations between station policy and the guidelines of I.C.6 has not been provided, nor has any justification for such deviations been provided. The following information is requested to complete the NRC staff review of this matter:

- 1. Describe who is authorized to hang tags, reposition valves, and perform intial component alignment. Define the term "qualified personnel" relative to hanging tags and repositioning valves.
- Provide the station policy concerning independent verification of tagging 2. for maintenance and for Watch Engineer's tags. Identify or provide copies of the procedure(s) describing this policy.
- Provide the station policy concerning first and second verification of 3. system realignment following maintenance. Identify or provide copies of the procedure(s) describing this policy.
