The U.S. Nuclear Regulatory Commission recently received a concern (AMS No. RIII-92-A-0017) regarding alleged falsification of information on a resume of a contractor at your LaSalle County Station. After a review of the concern, we concluded that there is no regulatory basis for further action on our part. We are providing details of this concern to you for your information only. No response is required, however, should you review this information and determine that the concern is substantiated and has regulatory significance, please notify the Region of this information.

We request that your response, if necessary, contain no personal privacy, proprietary, or safeguards information so it can be released to the public and placed in the NRC Public Document Room. If necessary, such information shall be contained in a separate attachment which will be withheld from public disclosure.

The enclosure to this letter should be controlled and distribution limited to personnel with a "need to know" until your investigation of the concern has been completed. The enclosure to this letter is considered Exempt from Public Disclosure in accordance with Title 10, Code of Federal Regulations, Part 2.790(a). Moreover, a copy of this letter, excluding the enclosures, will be placed in the NRC Public Document Room.

Any responses that may result from this letter will not be subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
