Late Thursday, June 21, this Board received copies of correspondence between UCLA and CBG which indicates that agreement cannot be reached between the two. The Board had earlier been advised orally by CBG of difficulties between these two parties. The correspondence indicates that in UCLA's view, offsite shipment cannot be accomplished on CBG's preferred schedule.

Consequently it is hereby ORDERED

- 2. All further proceedings in this docket are hereby suspended pending action on UCLA's motion to withdraw its license renewal application;

- 3. UCLA is to ship the nuclear fuel presently onsite to a suitable recipient as soon as reasonably practicable consistent with applicable regulations and with its security, public health, and safety obligations; and
- 4. UCLA is to immediately take all necessary steps to ensure that water cannot be intentionally or accidentally introduced into the reactor core so long as fuel is present in the core.
