
Dear Mr. Michaels:

The referenced order authorized the commencement of certain decommissioning tasks while fuel remained on site and required notification of the Commission when all fuel was removed from the facility prior to proceeding with the full decommissioning project according to the Cintichem Decommissioning Plan dated October 19, 1990, as amended.

As of February 1, 1992 all reactor fuel was removed from the facility and it was transferred to the Savannah River Site for reprocessing. Cintichem will now carry out the full decommissioning project as directed in the referenced order.
