SAFETY EVALUATION BY THE OFFICE OF NUCLEAR REACTOR REGULATION

SUPPORTING AMENDMENT NO. 9 TO

FACILITY OPERATING LICENSE NO. R-59

IOWA STATE UNIVERSITY

DOCKET NO. 50-116

1.0 INTRODUCTION

By letter of October 18, 1991, the Iowa State University (licensee) requested that changes be made to the Administrative Controls section (Section 6.0) of their Technical Specifications (TS) to make them compatible with organizational changes and to correct outdated references.

2.0 EVALUATION

The changes to Section 6.0 of the TS are summarized below.

6-11 - Updated Figure 6-1 to reflect changes in paragraphs 6.1.2 and 6.2.1.

With regard to paragraph 6.1.2, line 1, and 6.6.2(2)a., line 1, the change to make the Facility Director responsible for the facility license instead of the Nuclear Engineering Department Executive Officer is similar to the organization of other non-power reactors and is acceptable.

With regard to paragraphs 6.2.1, lines 4 and 9, it is acceptable to have the Reactor Safety Committee be composed of representatives from each of the colleges in the university in which research in the physical and life sciences and engineering is conducted rather than stipulating that representatives from five colleges have to be represented. This allows for flexibility in the licensee's TS with regard to future university reorganizations.

With regard to paragraph 6.2.1, line 12, it is acceptable to replace the Vice President for Academic Affairs (VPAA) with the Provost. The position of VPAA has been eliminated and the Provost is at least equivalent to that of the VPAA.

All other changes are changes to update reporting requirements and to indicate most recent standards. These are all acceptable.

3.0 ENVIRONMENTAL CONSIDERATION

This amendment involves changes in the category of recordkeeping, reporting, and administrative procedures and requirements. Accordingly, this amendment meets the eligibility criteria for categorical exclusion set forth in 10 CFR 51.22(c)(10). Pursuant to 10 CFR 51.22(b), no environmental impact statement or environmental assessment need be prepared in connection with the issuance of this amendment.

4.0 CONCLUSION

The staff has concluded, based on the considerations discussed above, that: (1) because the amendment does not involve a significant increase in the probability or consequences of accidents previously evaluated, or create the possibility of a new or different kind of accident from any accident previously evaluated, and does not involve a significant reduction in a margin of safety, the amendment does not involve a significant hazards consideration, (2) there is reasonable assurance that the health and safety of the public will not be endangered by the proposed activities, and (3) such activities will be conducted in compliance with the Commission's regulations and the issuance of this amendment will not be inimical to the common defense and security or the health and safety of the public.
