This refers to the routine inspection conducted by Mr. S. D. Reynolds, Jr. of this office on April 16-19, 1984 at Delta, Pennsylvania, of activities authorized by NRC License No. DPR-44 and to the discussions of our findings held by S.D. Reynolds, Jr. with Mr. D. Smith of your staff at the conclusion of the inspection and to a subsequent telephone discussion between S. D. Reynolds, Jr. and Mr. J. O'Rourke on May 1, 1984.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.
