SUBJECT: DEATH BY GUNSHOT OF ON DUTY SECURITY OFFICER INSIDE THE PROTECTED AREA

At approximately 8:00 p.m., February 12, 1992, an officer arrived to relieve an officer on patrol. The officer to be relieved could not be located or contacted via his radio. A search for the officer was implemented and the alarm station operator activated the officer's radio alert feature. A supervisor who was dispatched to assist in the search heard a radio beeping inside a Port-O-Let. Upon further investigation, the supervisor found the officer inside a locked Port-O-Let. After forcing the door open, the officer was found kneeling on the floor with his service weapon lying on the floor, wounded by an apparent self-inflicted gunshot. Responding medical personnel were unable to detect vital signs and declared the officer deceased. Local Law enforcement personnel responded and took charge of the investigation. The licensee conducted two searches of the areas the officer was responsible for patrolling and found nothing. *with negative results.*

Region II will continue to monitor the on-going investigation.
