This letter refers to the safeguards inspection conducted by Messrs. A. Della Ratta and G. C. Smith of this office on January 27 - 31, 1992, of activities authorized by NRC License Nos. NPF-39 and NPF-85 at the Limerick Generating Station Units 1 and 2 and to the discussions of our findings held by Mr. Della Ratta with Mr. R. J. Costagliola of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of security procedures and representative records, interviews with personnel, and observations by the inspectors. Additionally, the inspectors examined the Fitness-for-Duty (FFD) issues remaining open after our initial inspection of the FFD program, conducted on February 5-8, 1991.

We found that your physical security program is effective and directed toward assuring public health and safety. Appropriate management support for the program was also evident. Particularly noted during this inspection was the continuing management reviews of the overall implementation and program effectiveness, resulting in support for upgrades and enhancements, as necessary. No violations or safety concerns were identified.
