Enclosed is Amendment No. 12 renewing your NRC Material License No. 24-32202-01 in accordance with your request.

This amendment was generated using our new Web-Based Licensing System (WBL). This resulted in the deletion of Condition No. 13, as it appeared on Amendment No. 11, in favor of adding reference to 10 CFR Part 71, "Packaging and Transportation of Radioactive Material," in the Preamble language, located at the top of page 1 of your license. Additionally, Condition 14, regarding decommissioning financial assurance possession limits, as it appeared on Amendment No. 11, has been deleted from the license as it is not applicable to materials authorized under 10 CFR 35.200.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
