Merschoff of this office on September 14, 1995, concerning an enforcement conference that has been scheduled for October 4, 1995, at 2:00 p.m. The purpose of this conference is to discuss an apparent violation of 10 CFR Part 50.7, Employee Protection, that occurred in 1990. Selected enforcement conferences are designated as open for public observation in accordance with the Commission's trial program for conducting open enforcement conferences as discussed in the Federal Register, 57 FR 30762, July 10, 1992, and 59 FR 36796, July 19, 1994. This enforcement conference was not designated as an open enforcement conference and is closed for public observation.


