As indicated in the enclosed TWX report, the Radiation Effects
Reactor (RER) has been decommissioned in accordance with Lections
B and D of the Lockheed Decommissioning Plan, dated April 12,
1971. Based on the results of the inspection, it is recommended
that Operating License No. R-86 be terminated and that regulatory
control of the site be simultaneously transferred to the Radiological
Health Service of the Georgia Department of Public Health as described
in Section A of the Decommissioning Plan.

The results of the inspection, that was conducted on July 14, 1971, will be documented in an inspection report that will be forwarded to you in the near future.

SUBJECT: LOOKHEED AIRCRAFT CORP (RER) LICENSE R-86 DOCKET 50-172 (REF: CO REPORT 50-172/71-2)

REG II HAS DETERMINED BY INSPECTION THAT THOSE ACTIONS REQUIRED IN SECTION B&D OF THE LOCKHEED DECOMMISSIONING PLAN DATED A-12-71 HAVE BEEN SATISFACTORILY COMPLETED. THE 56 IRRADIATED FUEL ASSEMBLIES AND 8 IRRADIATED CONTROL ASSEMBLIES WERE SHIPPED TO SAVANNAH RIVER PROJECT. THE RER CER AND SDR CONTROL ROD DRIVE WERE DISPOSED OF AS A RADIO ACTIVE

WASTE BY CHEM-NUCLEAR CORP. THE 38 UNIRRADIATED FUEL ASSEMBLIES WERE SHIPPED TO DAK RIDGE (SEE CO REPORT 50-172/71-1).

ADDITIONALLY THE 2 LOCKHEED TOUR REACTORS WERE PURCHASED BY THE AEC DIVISION OF TECHNICAL INFORMATION AND BOTH UNITS HAVE BEEN RELOCATED IN OAK RIDGE. BASED ON THE ABOVE FINDINGS REG II RECOMMENDS THAT AEC LICENSE R-36 BE TERMINATED AND THAT CONCURRENTLY WITH TERMINATION OF LICENSE R-36 ALL CONCERNED AREAS OF THE FACILITY BE PLACED UNDER A STATE OF GEORGIA BYPRODUCT MATERIALS LICENSE.
