GEORGIA POWER COMPANY'S RESPONSE TO THE BOARD'S
INTERROGATORY REGARDING REVISION TO LER 90-006


On September 7, 1995, during the testimony of Mr. Thomas Webb, the Board requested Georgia Power to respond to an interrogatory regarding why the revision to LER 90-006 was "put on the shelf." Tr. 13258. The Board also indicated that Georgia Power should identify the information if it has already been provided to the Board. Id.

Georgia Power has reviewed the prefiled testimony of its witnesses and believes that the record already contains the reasons why the LER revision was delayed. Accordingly, Georgia Power provides the following interrogatory response, sponsored by Mr. Webb:

(Webb) In May of 1990, Ms. Amy Streetman, a corporate licensing engineer, informed me that the revision to LER 90-006 had been "put on the shelf" and indicated that she did not know why. As I stated at the hearing on September 7, 1995, "I received an explanation for this [delay in the revision] from Georgia Power counsel a couple of years ago." Tr. 13254. I have since reviewed pre-filed testimony of Georgia Power Company witnesses on the

diesel generator reporting issue and concluded that information contained in that testimony completely encompasses and exceeds the information provided to me by counsel. The testimony I am referring to is the direct pre-filed testimony of the following Georgia Power witnesses: Stringfellow at 11 (ff. Tr. 3930 (April 21, 1995)), Hairston at 9-15 (ff. Tr. 3531 (April 20, 1995)), McCoy at 17 (ff. Tr. 2839 (April 17, 1995)), Frederick at 3-6 (ff. Tr. 4125 (April 21, 1995)), and Aufdenkampe at 15-18 (ff. Tr. 4651 (May 17, 1995)).
