### AFFIDAVIT OF HARVEY HANDFINGER

I. Harvey Handfinger, being duly sworn, state as follows:

- I have sponsored prefiled rebuttal testimony, dated August 11, 1995, on behalf of Georgia Power Company in this proceeding; I was cross examined concerning that testimony on August 15, 1995.
- During the August 15, 1995 hearing, I testified concerning 1990 Maintenance Work Orders ("MWOs"), attached to my prefiled testimony as GPC Exhs. II-150A through 150E, which were used to correct an out-of-tolerance condition affecting the Plant Vogtle diesel generator air start admission valves.
- 3. Chairman Bloch requested that I submit an affidavit discussing the reason why one of the MWOs (No. 25003028; GPC Exh. II-150B) contained a cleanliness data sheet that was not included in the other MWOs. Tr. 11444-45. This affidavit provides the results of my review.

MWO 19003339 (GPC Exh. II-150E) states in block 23 (work instructions) that Zone IV housekeeping is to be maintained. In block 27 (work performed) it was documented that Zone IV housekeeping was maintained. Zone IV housekeeping is an acceptable cleanliness standard for this activity. MWO 29003147 (GPC Exh. II-150C) states in block 23 that this work is performed per procedure 27598-C. This would require that Zone IV housekeeping was met. Zone IV housekeeping is an acceptable cleanliness standard for this activity. MWO 19003340 (GPC Exh. II-150D) - I could find no reference to Zone IV housekeeping requirements in Block 23 of this MWO. Block 27 (work performed) documents that Zone IV housekeeping requirements were met. In addition, this work package has two QC HOLD/WITNESS POINTS sheets where cleanliness was verified by the Quality Control organization. MWO 29003028 (GPC Exh. II-150B) states in block 23 that the work is performed per procedure 27598-C. This would require that Zone IV housekeeping be maintained. Block 27 documents that this requirement was met. Zone IV housekeeping is an acceptable cleanliness standard for this activity. This is the only package that contained data sheet 1 of procedure 20427 (Maintenance of Cleanliness and Housekeeping). 8. In order to determine why data sheet 1 was included in MWO 29003028, I spoke with Mr. Dusty Adams, a maintenance foreman at Plant Vogtle, who signed data sheet 1 on 7-23-90. Mr. Adams informed me that he believed the data sheet was included in - 2 -

the MWO because there was a work item in the MWO to remove the air and lube oil lines to the air start distributor.

9. Based on my review of the documents and the amount of involvement of the Quality Control organization (as documented in the work packages), proper cleanliness was maintained during performance of the work under each of the MWOs.
