Joseph M. Farley Nuclear Plant - Units 1 and 2
Proposed Administrative Technical Specification Change

Gentlemen:

Recent facility organization changes have been proposed and evaluated for the Farley Nuclear Plant management which impact Figure 6.2-2 of the Unit 1 and 2 Technical Specifications. Alabama Power Company therefore submits this proposed Administrative Technical Specification Change in order to implement these management changes.

It is proposed that Figure 6.2-2 be changed to reflect two Assistant Plant Managers: an Assistant Plant Manager responsible for Operations, Maintenance and Technical Support, who will be required to hold a Senior Reactor Operator's License and a new Assistant Plant Manager who will have responsibility for Administration, Training, and Performance and Planning.

This change will provide the Assistant Plant Manager, responsible for the operation of the Farley Nuclear Plant, greater freedom from administrative and non-operations related responsibilities. This greater freedom will allow more management attention to be focused on the safe operation of the two Farley Nuclear Plant Units and therefore will enhance safety. Alabama Power Company plans to implement this change during the period that the NRC Staff is reviewing this Proposed Administrative Technical Specification Change. Attachment 1 lists the changed Technical Specification pages and includes the proposed changed pages for Units 1 and 2.

The proposed change does not involve a significant hazards consideration as defined in 10CFR50.92. This change is similar to example (i) of "Examples of Amendments that are Considered Not Likely to Involve Significant Hazards Considerations" listed in 48FR14870 dated April 6, 1983. This change is similar, in that it is administrative in nature and is proposed in order to have the technical specifications achieve consistency with the Farley Nuclear Plant's Facility Organization. The adoption of this proposed change will also constitute an additional limitation which is not presently included in the Technical Specifications.


The Plant Operations Review Committee has reviewed this proposed change and the Nuclear Operations Review Board will review this proposed change at a future meeting.

Pursuant to 10CFR170.21, the new rule on License Fees, the required License Amendment Fee of \$300.00 is enclosed. NRC approval of this change is requested by December 1, 1984.


