Dear Mr. Feigenbaum:

This letter refers to the inspection of your engineering activities, conducted by Messrs. L. Prividy and D. Moy from August 21-25, 1995, at the Seabrook Station in Seabrook, New Hampshire. The inspection was focused on issues important to public health and safety, and consisted of an independent evaluation of various engineering activities in the technical support group including plant modifications and the identification and technical resolution of problems. The preliminary inspection findings were discussed with Messrs. W. DiProfio and J. Vargas and other members of your staff on August 25, 1995.

Extensive planning and coordination have been instrumental in the high quality refurbishment of underground service water piping. Also, your development of a new computerized system for accessing real-time plant data has improved the performance monitoring of plant systems.

No reply to this letter is required. Your cooperation with us during this inspection is appreciated, and we would be pleased to discuss any questions you have concerning our conclusions.
