This refers to the routine safety inspection conducted by Mr. R. Paolino of this office on March 12-16, 1984, at Seabrook Station, Seabrook, New Hampshire, of activities authorized by NRC License No. CPPR-135 and to the discussions of our findings held by Mr. Paolino with Mr. J. Singleton and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.
