Gentlemen:

This refers to the inspection conducted under the Resident Inspection Program by Messrs. G. L. Constable, T. A. Flippo, and Ms. K. A. Whittlesey of this office during the period March 1 through April 30, 1984, of activities authorized by NRC Construction Permit CPPR-103 for the Waterford Steam Electric Station, Unit 3, and to the discussion of our findings with members of your staff at the conclusion of the inspection.

Areas examined during the inspection included technical specification review, human engineering walkdown, test results evaluation, surveillance and maintenance procedure reviews, Three Mile Island open items, followup on 50.55(e) items, open issues review, and emergency operating procedure verification. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. These findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.

One open item was identified in paragraph 6.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter, and submit written application to withhold information contained therein within 30 days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
