SUBJECT: MEETING WITH BOSTON EDISON COMPANY, MAY 11, 1984

Representatives of the Boston Edison Company (BECo) discussed their plans to use "soft" insulation (Fiberglass) in the drywell at the Pilgrim Nuclear Power Station during a meeting with NRC staff members in Bethesda, Maryland, on May 11, 1984. The previous insulation was removed as pipes were removed from the drywell during the current refueling outage.

The discussion indicated that BECo, with assistance from the General Electric Company, is utilizing the staff guidance provided in draft Regulatory Guide 1.82. As a result of its calculations, the licensee intends to increase the area of the suction screens in the drywell to eliminate any degradation of emergency core cooling system pump performance that might otherwise result from blockage of the screens by insulation debris following a loss-of-coolant accident.
