This refers to the routine safety inspection conducted by Mr. N. Terc of this office on May 21-23, 1984, at the Oyster Creek Nuclear Generating Station of emergency preparedness activities authorized by NRC License No. DPR-16 and to the discussions of our findings held by Mr. Terc with Mr. P. Fiedler and other members of your staff at the conclusion of the inspection.

The areas examined during this inspection were limited to the Emergency Plan Evaluation Report (EPER) issued as Appendix C of the Emergency Preparedness Appraisal Implementation Report (NRC Report No. 50-219/82-01) and to Revision 8 of your Emergency Plan.

Within the scope of this inspection, no violations were observed.

However, based on the discussion between Mr. Terc and Mr. Fiedler and other members of your staff, we understand that you will take corrective actions for each of the identified NRC concerns in the enclosed report. We understand that the corrective actions will be performed during the next revision to your emergency plan.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
