This refers to the routine safety inspection conducted by Mr. Ira Cohen of this office and other members of an NRC team on May 9-11, 1984 at the Oyster Creek Nuclear Generating Station of activities authorized by NRC License No. DPR-16 and to the discussions of our findings held by Mr. Cohen with yourself and other members of your staff at the conclusion of the inspection.

The area examined during this inspection was limited to observation of your annual exercise conducted on May 10, 1983. Within this area, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by a team of inspectors.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10 day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (2:5) 337-5223.
