Dear Sir:

The Nuclear Assurance Corporation understands that Transnuclear, Inc. has applied for an alternate spent fuel shipping route in New York state, between the West Valley facility and I-90, the New York Thruway.

This alternate route is required because of the de-rating of load carrying capability of a bridge at Gowanda, NY on the presently primary route approved on September 14, 1983.

By this letter, Nuclear Assurance Corporation joins in the request for approval of the alternate route and would use this alternate route until our primary route was again available or other conditions forced a re-routing.

The proposed alternate route follows the primary route to U.S. 62 at Collins, NY, then proceeds north on U.S. 62, 12 miles to Eden, NY; then proceeds west 5 miles to Gate 57A of I-90 (N.Y. Thruway); and then south and west to the Pennsylvania state line.

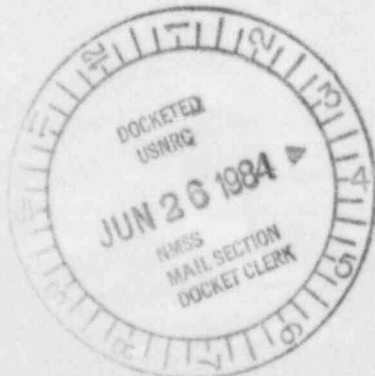
