In accordance with the Code of Federal Regulations, Title 10, Part 50.54(p)(2), Carolina Power & Light Company hereby transmits the original and three copies of select pages of Revision 9 to the Security Plan for the Shearon Harris Nuclear Power Plant.

The attached revision reflects the incorporation of the new photo identification badging system and describes the new badging format. Additionally, there are minor editorial changes that include the updating of position and organizational titles, and the deletion of requirements related to 10 CFR 73.55(d)(8) as set forth in the Federal Register of September 7, 1995 (60FR46497).
