

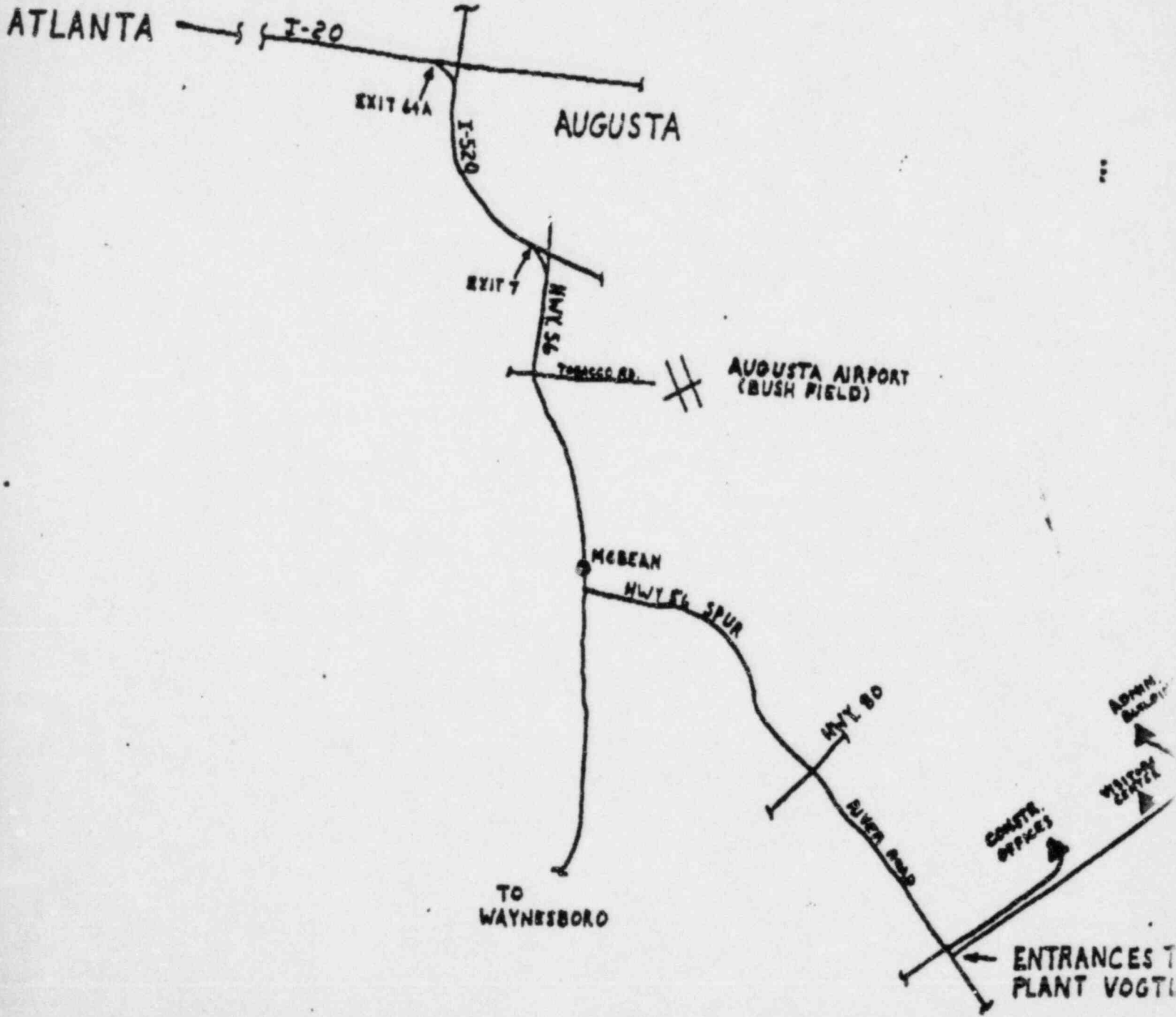
DIRECTIONS TO PLANT VOGTLE FROM THE AUGUSTA AIRPORT (BUSH FIELD)

Plant Vogtle is approximately 30 miles Southeast of Augusta. The travel time to the plant from Bush Field is about 40 minutes.

Exit from the airport on Tobacco Road and proceed 1.2 miles to Highway 56. Turn left onto Highway 56.

Go 9.8 miles and turn left onto Highway 56 Spur. Go 14.5 miles to the plant entrance (Note: Highway 56 Spur will change names to River Road at the intersection of Highway 80).

Turn left into the first plant entrance if going to the construction offices; or Turn left into the second plant entrance if going to the Visitors Center or Administration Building. The Visitors Center is a yellow building located approximately one mile up the plant access road, on the left.
