This refers to the special safety inspection conducted by Mr. H. Bicehouse of this office on August 20 and 21, 1984, at Delta, Pennsylvania, of activities authorized by NRC License No. DPR-44 and to the discussions of our findings held by Mr. Bicehouse with Mr. D. Smith of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection two violations of NRC requirements were identified. These violations were found to meet the mitigative tests described in 10 CFR 2, Appendix C, Section IV.A. In view of the circumstances surrounding this matter, we have exercised our discretion under the NRC Enforcement Policy and have chosen not to issue Notices of Violations for these violations.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1).
