REQUEST FOR ADDITIONAL INFORMATION

GRAND GULF SUBMITTAL DATED JUNE 29, 1984

 Section 1.3.3 states that the Director, Quality Assurance is assisted by the Manager, Nuclear Site QA; Manager, Programs QA; and Manager, Supplier QA. Paragraph 1.3.4 specifically describes the authority and responsibilities of the Manager, Nuclear Site QA. However, similar descriptions for the Manager, Programs QA, and the Manager, Supplier QA, are not provided.

Provide a description of authority and responsibilities for the Manager, Programs QA, and Manager, Supplier QA, in the same general format as paragraph 1.3.4.

- 2. Section 1.3.7 deletes the following responsibilities from the Nuclear Licensing and Safety Staff (formerly Nuclear Services Staff):
 - a) The management of the Nuclear Fuel Cycle including the control of the design activities associated with nuclear core design.
 - b) The establishment and implementation of the Environmental Surveillance Program.
 - c) Maintenance of the General Office Nuclear Records System
 - d) Provide technical assistance and support in the areas of Procurement. Safety Analysis, Health Physics, Environmental Assessment, Emergency Planning, Nuclear Engineering and Fire Protection.
 - e) Provide support to the Vice President Nuclear Operations in matters related to administration and cost control.

Section 1.3.16 describes functions of the Nuclear Support Department which includes several, but not all, of these deleted functions. Identify the organization responsible for the deleted activities or provide justification for their deletion.

3. Section 1.3.17 states that the Director, Nuclear Engineering and Construction, is assisted by the Manager, Nuclear Plant Engineering; Manager, Unit No. 2 Construction; and Manager, Plant Outages. The organization chart (Attachment B to AECM-84/0332) indicates that the Bechtel Assistant Project Manager also reports to the Director, Nuclear Engineering and Construction. Responsibilities of the Bechtel Assistant Project Manager within the Nuclear Engineering and Construction Organization are not described.

Describe the duties and responsibilities of the Bechtel Assistant Project Manager within the Nuclear Engineering and Construction Organization.
