This letter is in response to your additional information letter request dated March 16, 2020.

- 1) Best Theratronics Ltd. (Material License: 45-31299-01) is withdrawing the request to change the address of the license to the Canadian manufacturing location. This request originated as a recommendation from an NRC inspector, who conducted an audit in December 2019.

All original records related to Best Theratronics' manufactured products and services, including those for services work at locations where the NRC has jurisdiction over, are maintained and accessible electronically per 10 CFR 110.53(2).

- 2) Mr. Eric McGinnis has 33 years of continuous experience servicing the devices listed on Best Theratronics' materials license (45-31299-01). As a senior service technician, Mr. McGinnis has been cross trained with Mr. Victor Moga, the previous manager of the material license responsibilities, over the past 8 years. This training has included experiences related to supervising and evaluating other persons authorized to use, or supervise the use of, licensed material while performing activities authorized by the material license. Mr. Eric McGinnis has been cleared, including by the Federal Bureau of Investigation based on fingerprint and criminal history records check, and is deemed trustworthy and reliable.
