RADIOLOGICAL EFFLUENT TECHNICAL SPECIFICATIONS SUBMITTAL

Gentlemen:

In accordance with the provisions of 10 CFR 50.90 as required by 10 CFR 50.59(c)(1), Georgia Power Company (GPC) hereby amends our submittal of August 1, 1984, which proposed changes to the Plant Hatch Units 1 and 2 Technical Specifications (Appendices A and B to the Operating Licenses). This application amends the proposed Technical Specifications as submitted August 1, 1984, by the correction of technical inaccuracies and typographical errors, and by the addition of change bars in the margins in our previous submittal. The technical inaccuracies are: (1) the implication in table notation 4 on page 3.14 of Unit 1 RETS is that there is a trip function associated with the instrument, when there is not; (2) that the doses on page 3.15-7 of Unit 1 are averaged over the elapsed quarter rather than projected for the remainder of the quarter; and (3) in the bases for both Units for the explosive gas mixture specification, oxygen is described as flammable rather than as supporting combustion.

Attachments 1, 2, and 3 are respectively the insertion instructions and proposed amendment pages for Unit 1 Technical Specifications, Unit 2 Technical Specifications and Environmental Technical Specifications. The proposed changes in this submittal do not alter the conclusions of the significant hazards analysis or the safety evaluation provided by our letter of August 1, 1984.


Pursuant to the requirements of 10 CFR 50.91, Mr. J. L. Ledbetter of the Environmental Protection Division of the Georgia Department of Natural Resources will be sent a copy of this letter and all applicable attachments.
