This transmits the June 12 - July 10, 1984 resident inspection findings by Messrs. T. Foley and D. Trimble at the Calvert Cliffs Nuclear Power Plant, Lusby, Maryland. Those findings were based on observation of activities, interviews, independent measurements, and document reviews, and have been discussed with Mr. Carroll of your staff.

An apparent violation of NRC requirements is cited in Appendix A and categorized under the revised NRC Enforcement Policy, 10 CFR 2 Appendix C (47FR9987, March 8, 1984). A reply is required in accordance with Appendix A. The requirement that you reply is exempt from clearance by the Office of Management and Budget under the Paperwork Reduction Act of 1980, PL 96-511.

In addition, we have reviewed your letter dated June 29, 1984, in response to our letter, dated June 1, 1984 (Inspection Report No. 84-01, containing violation of Technical Specification 3.6.4.1, Containment Isolation Valves). Thank you for informing us of the corrective and preventative actions documented in your letter. These actions will be examined during future inspection of your licensed program.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter and submit written application to withhold information contained therein within 25 days of the date of this letter. Such application must comply with 2.790(b)(1).


