Subject: Inspection No. 50-388/84-34

This refers to the special safety inspection conducted by myself and others of this office on July 26-31, 1984, at the Susquehanna Steam Electric Station, Unit 2, Berwick, Pennsylvania, of activities authorized by NRC License No. NPF-22. This also refers to the Confirmatory Action Letter (CAL 84-14) associated with the loss of alternating current power event of July 26, 1984, to the Confirmatory Order on the same subject dated July 27, 1984, to the discussions of the results of your investigation and our inspection findings held with Mr. H. Keiser and others of your staff at the conclusion of the inspection, and to the restart approval letter dated July 31, 1984.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements. These items will be the subject of separate correspondence at a later time.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
