This refers to the routine safety inspection in the area of whole body counting conducted by Mr. J. J. Kottan of this office on May 11, 1984 at the Oyster Creek Nuclear Generating Station, Forked River, New Jersey of activities authorized by NRC License No. DPR-16 and to the discussions of our findings held by Mr. Kottan with Mr. P. Fiedler and others of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Within the scope of this inspection, no violations were observed.
